Order No 81 dated 08.08.2023

Today is fixed for evidence of C.S.W.4.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present in Court by filing hazira.

Ld. Advocates for the accused persons and Ld. Special P.Ps. are present.

C.S.W.4 namely Bikash Minj is present today.

Now the record is taken up for recording evidence of C.S.W.4 namely Bikash Minj.

At this juncture, two separate petitions have been filed on behalf of the accused nos.(A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil and (A-13) Adil Sk. @ Abdullah @ Asadulla @ Ajit Sk. stating that the accused/petitioners intend to plead guilty in the instant case and therefore it is prayed for passing order to accept the petitions for “plea of guilty” of the accused/petitioners on the ground stated therein.

Copy served.

Let those be kept with the record.

Ld. Special P.P. submits that the petitions filed today on behalf of the accused nos.(A-11) and (A-13) be disposed of at first and then to proceed with the recording evidence of C.S.W.4 namely Bikash Minj.

Accordingly, C.S.W.4 namely Bikash Minj is released today without examination.

Fix **17.08.2023** for hearing of the two petitions dated 08.08.2023 filed on behalf of the accused nos.(A-11) and (A-13) praying for accepting the petitions for “plea of guilty” of the accused/petitioners.

Written objection, if any, in the meantime.

The accused persons nos.(A-11) and (A-13) are remanded to J.C. till 17.08.2023.

In view of such fact, evidence of C.S.W.4 namely Bikash Minj is kept in abeyance till disposal of the two petitions dated 08.08.2023 filed on behalf of the accused nos.(A-11) and (A-13) praying for accepting the petitions for “plea of guilty” of the accused/petitioners.

Ld. Advocate for the accused no.(A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassan files a petition stating that the accused/petitioner has been suffering from “Hydrocele” and his condition is very critical and therefore it is prayed for necessary direction upon the Superintendent of Presidency Correctional Home to provide proper medical treatment to the accused/petitioner and if required, from outside the Jail Hospital and call for a report in this regard.

Heard the Ld. Advocate for the accused no.(A-7).

In view of the above, the Superintendent of Presidency Correctional Home is directed to ensure proper medical treatment of the accused/petitioner as per prescription of the Medical Officer and submit a report in this regard by the next date fixed i.e. on 17.08.2023 positively.

Continued order no.81 dated 08.08.2023

One petition has been filed on behalf of the accused person no.(A-20) Sk. Rejaul stating that the accused person is on Court bail and in pursuance to the direction of the Hon'ble High Court at Calcutta, the accused person has to attend the Local Police where he resides, but due to unavailability of the concerned officer attendance of the accused person before the concerned P.S. could not be done on Sunday and therefore it is prayed for necessary direction upon the Officer-in-charge of Rajabagan P.S. to accept the hazira of the accused without any delay.

Heard both sides.

In view of such fact, the O/C, Rajabagan P.S. is directed to do the needful in accordance with Law with regard to the accused person namely (A-20) Sk. Rejaul.

Fix **11.09.2023** for production of rest of the accused persons and appearance of the accused persons and further order.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10) and (A-12)) are remanded to J.C. till 11.09.2023.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.
