To-day is fixed for production of the accused persons and appearance of the accused persons and hearing of the petition u/s 227 of Cr. P.C. dated 18.09.2023 filed on behalf of the accused nos.(A-11), (A-12) and (A-13) praying for discharging the accused/petitioner nos.(A-11), (A-12) and (A-13) from the ambit of the section of 14 A(b) of Foreigners' Act.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are found present before this Court and hazira has been filed on their own behalf.

None turns up on behalf of the accused persons.

No report pertaining to medical treatment provided to the accused no.(A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassan has yet been filed by the concerned Correctional Home in terms of order no.88 dated 28.09.2023 passed by this Court.

Today Ld. Lawyers did not attend the Court proceedings due to resolution taken by local Bar.

Accordingly, the case is adjourned.

The accused no.(A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassan files a petition in person stating that the accused/petitioner has been suffering from tissue pain and for that reason the Jail Hospital and the outside Jail Hospital have prescribed only Paracetamol and painkiller tablets and no X-ray or USG has yet been done by both the Hospitals and as such the accused/petitioner has been suffering from intense pain probably from clotting blood and therefore it is prayed for passing necessary direction upon the concerned Correctional Home Authority to provide proper medical treatment to the accused/petitioner.

Heard the accused/petitioner.

In view of the above, the Superintendent of Presidency Correctional Home is to ensure continuous medical treatment of the accused/petitioner as per prescription of the Medical Officer and also to address the pain and suffering as stated by the accused namely Dilwar Hossain @ Umar @ Nurul @ Ali Hassan before this Court due to clotting of blood and then a report regarding treatment provided to the accused person be submitted by the next date fixed positively.
