Perused the CIS copy of order dated 13.10.2023 passed by the Hon'ble High Court at Calcutta in connection with CRM (DB) 4490 of 2022 (CRAN 1 OF 2023) wherein the Hon'ble High Court at Calcutta has been pleased to pass an order to the extent that *"Accordingly, on humanitarian ground, conditions of bail imposed upon the petitioner i.e. to remain within the municipal limits of the city of Kolkata and report to the Officer-in-charge of the police station where he is presently residing i.e. Taltala/Rajabagan Police Station once in a week are waived. He is directed to not to leave the district of Birbhum except for the*
