On submission of both sides, fix **06.12.2023** for production of the accused persons and appearance of the accused persons and further hearing of the petition u/s 227 of Cr. P.C. dated 18.09.2023 filed on behalf of the accused nos.(A-11), (A-12) and (A-13) praying for discharging the accused/petitioner nos.(A-11), (A-12) and (A-13) from the ambit of section of 14 A(b) of Foreigners' Act and passing order in respect of the petition dated 18.09.2023.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 06.12.2023.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.
