To-day is fixed for hearing on the point of re-casting of charge.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons are present.

Ld. Special P. P.-in-charge is present.

One CIS copy of order dated 09.01.2024 passed by the Hon'ble High Court at Calcutta in connection with C.R.M. (DB) 3324 of 2022 with CRAN 3 of 2023 has been filed on behalf of the accused no.(A-8) Abdul Majed.

Perused the CIS copy of order dated 09.01.2024 wherein the Hon'ble High Court at Calcutta has been pleased to observe as follows:

“Under such circumstances, conditions of bail imposed on the petitioner to stay within the municipal limits of Kolkata and to report to the Officer-in-charge of the police station concerned within whose jurisdiction he is presently residing i.e. Tiljala P.S. once in a week are waived and he is directed to meet Officer-in-charge where he ordinarily resides i.e. Bhagwangola P.S. once in a week until further orders.

Other conditions shall continue.

CRAN 3 of 2023 is disposed of.”

Let the same be kept with the record.

The record is taken up for hearing on the point of re-casting of charge.

At this juncture, a petition has been filed on behalf of the Prosecution stating that C.D. is very much required to be looked into the matter and therefore time has been sought for to produce the C.D. on the next date fixed.

Heard both sides on the point of adjournment.

Prayer for time is considered and allowed with a direction upon the I.O. of this case to ensure production of the C.D. on the date fixed.

On submission of both sides, fix **24.01.2024** for hearing on the point of re-casting of charge.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 24.01.2024

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

Let a copy of this order be sent to the I.O. of this case through concerned O/C for information and necessary compliance.
