To-day is fixed for hearing of the petition dated 24.01.2024 filed on behalf of the accused person no.(A-20) Sk. Rejaul @ Kiran @ Rutu praying for excluding the relevant sections of explosive substance Act at the time of framing of charge against the accused person and hearing on the point of re-casting of charge.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons and the Ld. Special P. P. are present.

The record is taken up for hearing on the point of re-casting of charge.

At this juncture, a petition has been filed on behalf of the Prosecution stating that Ld. Special P.P. is unable to conduct the hearing today on account of his illness and therefore it is prayed for an adjournment.

Heard both sides on the point of adjournment.

Prayer for an adjournment is considered and allowed on consent.

One medical report in respect of the accused person no.(A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassain along with a forwarding letter bearing no.2534/IMB dated 28.02.2024 has been received from the Superintendent of Presidency Correctional Home in terms of order no.98 dated 08.02.2024 passed by this Court.

Perused the same and let those be kept with the record.

In view of such fact, the Superintendent of Presidency Correctional Home is further directed to render continuous medical treatment to the accused person no.(A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassain as per prescription of the Registered Medical Practitioner deputed in the Correctional Home and as per the West Bengal Correctional Services Act, 1992.

On submission of both sides, fix **07.03.2024** for hearing of the petition dated 24.01.2024 filed on behalf of the accused person no.(A-20) Sk. Rejaul @ Kiran @ Rutu praying for excluding the relevant sections of explosive substance Act at the time of framing of charge against the accused person and hearing on the point of re-casting of charge.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 07.03.2024

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

Let a copy of this order be sent to the I.O. of this case through concerned O/C with a direction to ensure production of the C.D. on the date fixed.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary compliance.
