(DB) 667 of 2023 with CRAN 1 of 2023, Ld. Counsel for the accused person namely (A-15) Manirul Islam submits before this Court that vide order dated 08.03.2024 the Hon'ble Court has been pleased to waive the conditions of bail imposed upon the accused/petitioner.

Ld. Counsel for the accused person namely (A-15) Manirul Islam further submits that present address of the accused/petitioner is at Vill.-Madhyapara, Ichhakhali, P.O.-Kulgachi, P.S.-Raghunathgarg, Dist.-Murshidabad, Pin. No.742216 and he prays for taking note of the present address of the accused person in compliance with the order dated 08.03.2024 of the Hon'ble Court.

Perused the order dated 08.03.2024 wherein the Hon'ble High Court at Calcutta has been pleased to observe inter alia as follows:

“It appears from the report petitioner has complied with the conditions of bail imposed upon him vide order dated 20.03.2023 i.e. to reside within the municipal limits of the City of Kolkata and to report to the Officer-in-charge, Beniapur Police Station where he is presently residing once in a week.

Under such circumstances, conditions of bail imposed upon the petitioner i.e. to reside within the municipal limits of the City of Kolkata and to report to the Officer-in-charge, Beniapur Police Station where he is presently residing once in a week are waived. He is directed to meet the Officer-in-charge, Special Task Force (STF) Police Station once in a month until further orders.

Other conditions of bail shall continue.

The application being CRAN 1 of 2023 is thus, disposed of.”
