In view of such fact, the Superintendent of Dum Dum Central Correctional Home is directed to continue providing adequate medical treatment and diet to the accused person no.(A-10) Jahidul Islam @ Kausar @ Boma Mijan as per prescription of the Registered Medical Practitioner deputed in the Correctional Home and as per the West Bengal Correctional Services Act, 1992.

Received one compliance report vide letter no.4849/WO dated 24.04.2024 from the Superintendent of Presidency Correctional Home in terms of order no.102 dated 21.03.2024 passed by this Court with regard to allowing the accused person namely (A-13) Adil Sk. @ Abdullah @ Asadulla @ Ajit Sk. to avail the parole on 05.04.2024 to perform the kabar Jiyarat (Dhuwa) of his deceased sister at Elizabad, P.O. -Bhasaipaikar, P.S.- Shamshergang, Murshidabad and nearby Kabarsthan.

Let the same be kept with the record.

Now, the record is taken up for hearing on the point of re-casting of charge.

Heard both sides in part.

Fix **03.05.2024** for further hearing on the point of re-casting of charge and passing order.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 03.05.2024

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

C.D. be retained.
