To-day is fixed for further hearing on the point of re-casting/alteration of charge and passing order and also hearing of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India to prevent any damage after maintaining all legal formalities.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person namely (A-10), Jahidul Islam @ Kausar @ Boma Mijan is not produced before this Court today.

Received one Radiogram vide no.9458/AB-I dated 03.06.2024 from the Superintendent of Dum Dum Central Correctional Home stating that the accused person could not be produced before this Court today due to non availability of Police Escort and vehicle.

Perused the same and let the same be kept with the record.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons and the Ld. Special P. P. are present.

In view of the non production of the accused person namely (A-10), Jahidul Islam @ Kausar @ Boma Mijan and also in view of the resolution "not to pass any adverse order" taken by local Bar, this Court is not in a position to proceed with the further hearing on the point of re-casting/alteration of charge and also hearing of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India to prevent any damage after maintaining all legal formalities.

Accordingly, the case is adjourned for the ends of justice.

The Superintendent of Dum Dum Central Correctional Home is directed to take necessary steps to ensure production of the accused person namely (A-10), Jahidul Islam @ Kausar @ Boma Mijan before this Court on the next date fixed.

On submission of both sides, fix **27.06.2024** for production of the accused persons, appearance of the four accused persons, further hearing on the point of re-casting/alteration of charge and passing order and also hearing of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India to prevent any damage after maintaining all legal formalities.
