To-day is fixed for production of the accused persons, appearance of the four accused persons, further hearing on the point of re-casting/alteration of charge and passing order and also hearing of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India to prevent any damage after maintaining all legal formalities.

The accused person nos.(A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are produced before this Court from J.C.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons and the Ld. Special P. P. are present.

One letter is received from the Superintendent Dum Dum Central Correctional Home vide Memo No. 9778/RB dated 14.05.2024 in respect of convict Izaj Ahmed @ Moti Ahmed @ Jitu @ Izaj.

Let it be kept with the record.

Now the record is taken up for further hearing of the petition on the point of re-casting/alteration of charge.

At this juncture, Ld. Counsels on behalf of the accused persons file a petition praying for an adjournment on the grounds of unavoidable circumstances.

Ld. Special P.P. raised no objection with regard to the prayer for adjournment.

Heard all sides on the point of adjournment.

Prayer is considered and allowed as a last chance.

Accordingly, the case is adjourned for the ends of justice.

On submission of both sides, fix **29.07.2024** for production of the accused persons, appearance of the four accused persons, further hearing on the point of re-casting/alteration of charge.

The record is now taken up for hearing of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India to prevent any damage after maintaining all legal formalities.

Prior to passing any order in respect of the petition dated 21.05.2024 filed by the Assistant Commissioner of Police, S.T.F., Kolkata praying for allowing the prosecution to deposit the seized currency notes amounting to Rs.1,00,000/- at Government Treasury/Reserve Bank of India, one detailed report from the I.O should be called for stating from whom the alleged currencies were recovered and seized and also whether any claimant is there or not with

regard to the currency notes of Rs. 1,00,000/ and whether those currency notes will not be required during the trial of this case.

Todate i.e **29.07.2024** for submission of I.O's report.

One petition is filed by the Ld. Advocate on behalf of accused person Dilwar Hossain praying for passing a direction upon the Superintendent of Presidency Currency Home regarding the operation of Hernia of the accused person.

The Superintendent of Presidency Correctional Home is directed to take necessary steps at once for providing adequate medical treatment to the accused person namely Dilwar Hossain as per advice of the registered medical practitioner of the Correctional Home as per the provision of West Bengal Correctional Services Act ,1992 and submit a compliance report before this Court on the next date fixed i.e. on 29.07.2024.

Another petition is filed by the Ld. Advocate on behalf of accused person Md. Adil Sk praying for passing a direction upon the Superintendent of Presidency Currency Home regarding his medical diet.

The Superintendent of Presidency Correctional Home is directed to take necessary steps regarding the medical diet of the accused person namely Md. Adil Sk as per advice of the medical practitioner of the Correctional Home as per the provision of West Bengal Correctional Services Act ,1992 and submit a compliance report before this Court on the next date fixed i.e. on 29.07.2024.

The accused person nos.(A-2), (A-3), (A-4), (A-7),(A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 29.07.2024.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

C.D. be returned.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home along with the copies of the petition of the accused persons namely (A-7) Dilwar Hossain and (A-13) Md. Adil Sk for information and necessary action.
