Today is fixed for hearing of the petition dated 12.06.2024 filed on behalf of the convict (A-8), Izaj Ahmed @ Moti Ahmed @ Jitu @ Izaj @ Md. Yousuf together with the report received from the Ld. Secretary, the District Legal Service Authority, Kolkata vide no.1827/DLSAK/2024 dated 20.09.2024.

Today is also fixed for hearing of the petition dated 08.11.2024 filed on behalf of convict no. (A 19) Abdul Rahim along with the report submitted by Presidency Correctional Home vide letter no. 13780/WO dated 16.11.2024.

Ld. P.P and the Ld. Counsel for the convict (A-8), Izaj Ahmed @ Moti Ahmed @ Jitu @ Izaj @ Md. Yousuf are present today.

Now the record is taken up for hearing of the petition dated 12.06.2024 filed on behalf of the convict (A-8), Izaj Ahmed @ Moti Ahmed @ Jitu @ Izaj @ Md. Yousuf in presence of both sides.

Ld. Counsel for the convict submits that the convict was arrested on 24.09.2019 and he was convicted on 04.11.2022 and the period of conviction will be set off as per Section 428 of the Cr. P.C as he is also convicted in Sessions Case 15 of 2020 and Sessions Case 20 of 2020 and he prays for passing necessary order.

At this stage, Ld. P.P submits before this Court that the Ld. Counsel for the convict has not supplied the copy of the petition dated 12.06.2024 to prosecution side and he needs to take instructions in the matter. In view of such circumstances, the Ld. Counsel for the convict is directed to supply copy of the petition dated 12.06.2024 to the prosecution in the meantime.

To date i.e **30.11.2024** for hearing of the petition dated 12.06.2024 filed on behalf of the convict (A-8), Izaj Ahmed @ Moti Ahmed @ Jitu @ Izaj @ Md. Yousuf together with the report received from the Ld. Secretary, the District Legal Service Authority, Kolkata vide no.1827/DLSAK/2024 dated 20.09.2024.

Now the petition dated petition dated 08.11.2024 filed on behalf of convict no. (A 19) Abdul Rahim along with the report submitted by Presidency Correctional Home vide letter no. 13780/WO dated 16.11.2024 is taken up for hearing in presence of both sides.

Ld. Counsel for the convict, Abdul Rahim and Ld. P. P leave the matter upon the discretion of this Court.

Heard. Perused the report of Superintendent of Presidency Correctional Home wherefrom it is revealed that during the proposal of transfer of the convict from the Presidency Correctional Home to the Behrampur Central Correctional Home, he has informed that his residential address is at Vill. Kohetpur under Samsorganj Police Station,

Murshidabad District. In this regard, one prayer for transfer signed by the convict inmate and one Police report obtained by the Behrampur Central Correctional Home with regard to parole proposal has confirmed the address of the convict and the same is stated to be Vill. Kohetpur under Samsrganj Police Station, Murshidabad District.

In view of the police report, the Superintendent of Presidency Correctional Home is at liberty to make necessary entries following the rules as laid down in the West Bengal Correctional Services Act, 1992.

With the above observation, the petition dated 08.11.2024 filed on behalf of convict no. (A 19) Abdul Rahim is disposed of.
