The accused person nos. (A-2) Ahammad Ali @ Kalu, (A-4) Md. Paigambar Sk. (A-7) Dilwar Hosssain @ Umar @ Nurul @ Ali Hassan, (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil, (A-12) Abdul Karim @ Karim Sk. @ Iqbal and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk. are produced before this Court from the J.C. in physical mode.

Received one report from the Superintendent of Presidency Correctional Home, Alipore, Kolkata-27 vide letter no.2466/AB dated 18.02.2025 with regard to production of the accused persons in virtual mode.

Let the same be kept with the record.

The accused person namely (A-10) Jahidul Islam @ Kausar @ Boma Mijan is produced before this Court from J.C. in physical mode.

The accused person no.(A-3) Nur Alam Momin @ Noor Alam @ Alam is not produced before this Court from the J.C.

Received one report with regard to non production of the accused person no.(A-3) Nur Alam Momin @ Noor Alam @ Alam before this Court from the Superintendent of Presidency Correctional Home vide letter no.2484/AB dated 18.02.2025.

Perused the report bearing letter no.2484/AB dated 18.02.2025 wherein it has been stated that the accused person no. (A-3) Nur Alam Momin @ Noor Alam @ Alam was produced before the Court of Ld. Special Judge, NIA, Patna, Bihar in connection with Special Case no.01 of 2018 on 24.09.2024 and thereafter the said accused person has not yet been returned from the Correctional Home at Patna, Bihar and as such the Presidency Correctional Home Authority is unable to produce the accused person before this Court.

Let the same be kept with the record.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court Bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons are present.

Ld. Special P. P. is present by filing hazira.

The accused persons are identified by the concerned Jail Authorities and they expressed before this Court that they could see and hear the entire court proceedings without any technical glitch.

In view of the non production of the accused person no.(A-3) Nur Alam Momin @ Noor Alam @ Alam before this Court, this Court has no other option left but to adjourn the further hearing of the petition on the point of re-casting/alteration of charge.

Accordingly, the case is adjourned today for the ends of justice.

Ld. Counsels for the parties are directed to remain present and to come ready with hearing of the recasting of the charge and or submission, if any, on the next date fixed in this regard.

The Superintendent of Presidency Correctional Home is also directed to take necessary steps to ensure production of the accused person no. (A-3) Nur Alam Momin @ Noor Alam @ Alam before this Court on the next date fixed.

Fix **19.03.2025** for production of the accused persons, appearance of the four accused persons and further hearing on the point of re-casting/alteration of charge.

The accused person nos. (A-2), (A-4), (A-7),(A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 19.03.2025.

To-date i.e. on **19.03.2025** for production of the accused person no.(A-3) before this Court.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.
