To-day is fixed for production of the accused persons in physical mode, appearance of the four accused persons and passing order on the point of re-casting/alteration of charge.

The accused person nos. (A-2) Ahammad Ali @ Kalu, (A-3) Nur Alam Momin @ Noor Alam @ Alam, (A-4) Md. Paigambar Sk. (A-7) Dilwar Hosssain @ Umar @ Nurul @ Ali Hassan, (A-10) Jahidul Islam @ Kausar @ Boma Mijan , (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil, (A-12) Abdul Karim @ Karim Sk. @ Iqbal and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk. are produced before this Court from the J.C. in physical mode.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court bail are present before this Court by filing hazira.

Ld. Counsels for the accused persons are present.

Ld. Special P. P. is present by filing hazira.

The record is taken up for passing order on the point of re-casting/alteration of charge.

At this juncture, Ld. Counsel for the accused persons by filing a petition states that Ld. Senior Counsel is inclined to file a petition on the next date fixed and therefore an adjournment has been prayed for.

Heard both sides.

Prayer for an adjournment is considered and allowed.

A petition has been filed on behalf of the accused persons namely (A-2) Ahammad Ali @ Kalu and (A-4) Md. Paigambar Sk. praying for accepting the "plead guilty" of the accused/petitioners and imposing the minimum punishment upon the accused/petitioners on the ground stated therein.

Let the same be kept with the record.

A petition has been filed on behalf of the accused person namely (A-10) Jahidul Islam @ Kausar @ Boma Mijan stating that for the few weeks the Correctional Authority did not bring the accused/petitioner to the designated place to perform his Jummah prayer and therefore prays for a direction upon the Superintendent of Dum Dum Central Correctional Home to allow the accused/petitioner to perform his Jummah prayer on every Friday on the ground stated therein.

Heard both sides.

In view of the prayer made in the petition, the Superintendent of Dum Dum Central Correctional Home is directed to do the needful as per the Jail Code.

To-date i.e. on **23.07.2025** for hearing of the petition dated 27.06.2025 filed on behalf of the accused persons namely (A-2) Ahammad Ali @ Kalu and (A-4) Md. Paigambar Sk. praying for accepting the “plead guilty” of the accused/petitioners.

Written objection, if any, in the meantime.

The accused person nos. (A-2), (A-3), (A-4), (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 23.07.2025.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

Let a copy of this order be sent to the I.O. of this case through the concerned O/C with a direction to take necessary steps to ensure production of the C.D. before this Court on the next date fixed positively.

Let a copy of this order along with a copy of the petition filed today by the accused person namely Jahidul Islam @ Kausar @ Boma Mijan be sent to the Superintendent of Dum Dum Central Correctional Home for information and necessary action.
