Order no.48 dated 05.08.2025

Today is fixed for appearance & production of the accused persons, hearing of the petition dated 07.07.2025 filed on behalf of the accused Dilwar Hossain and passing order on the point of alteration of charge.

The accused persons Abdul Majed, Abdul Matin, Sk Rejaul and Maniraul Islam, on court bail, are present by filing hazira.

The accused persons (A-7) Dilwar Hossain @ Umar @ Nurul @ Ali Hassan, (A-10) Jahidul Islam @ Kausar @ Boma Mijan, (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil, (A-12) Abdul Karim @ Karim Sk. @ Iqbal and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk. are produced before this Court from the J.C.

Ld. Advocates for the accused persons are present.

Ld. Public Prosecutor-in-charge is also present.

Now, the record is taken up for hearing of the petition dated 07.07.2025 filed on behalf of the accused Dilwar Hossain.

Ld. Advocate for the accused Dilwar Hossain submits that this accused is suffering from hernia and even after providing treatment to the accused by the Presidency Correctional Home at SSKM Hospital, Kolkata, his health condition does not get improved. So, he prays for allowing the prayer to allow the accused to be treated at Islamia Hospital at his own cost.

Ld. Public Prosecutor raises objection.

Heard. Perused. Considered.

It appears that the accused person is getting all adequate medical facilities for his treatment at SSKM Hospital, Kolkata.

Hence, considering the facts and circumstances, I do not find any merit in the prayer of the accused Dilwar Hossain to be treated at Islamia Hospital at his own cost.

Accordingly, the petition dated 07.07.2025 filed by the accused Dilwar Hossain stands disposed of in the negative.

Now, the record is taken up for passing order on the point of alteration of charge.

I have carefully perused the entire case record.

It appears that charge has already been framed against the accused persons.

On careful perusal of the case record, I do not find any cogent and convincing material to alter the charge against the accused persons at this stage.

Accordingly, now the case record be fixed for recording of evidence.

Fixing **02.09.2025** for production & appearance of the accused persons and recording of evidence.

Prosecution is directed to take proper steps in this regard.

The accused persons, on bail, are as before.

The accused persons be remanded to J/C till 02.09.2025.
