The specimen handwriting and signature of the accused Shish Muhammad containing in 09 pages are marked as **X for identification collectively.**

Further examination in Chief of P.W.-2 is deferred on the prayer of Ld. Special P.P.

Fixing **24.09.2025** for production of the accused persons in physical mode, appearance of the four accused persons and further examination in chief of P.W.-2.

Re-issue summon in the name of P.W.-2, Bikash Minj with a direction to remain present before this court on the next date fixed for adducing further evidence.

The accused person nos. (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 24.09.2025.
