To-day is fixed for production and appearance of the accused persons and further examination of P.W.2.

The accused person namely (A-12) Abdul Karim @ Karim Sk. @ Iqbal is produced before this Court from J.C. in virtual mode.

The accused person nos.(A-7) Dilwar Hosssain @ Umar @ Nurul @ Ali Hassan, (A-10) Jahidul Islam @ Kausar @ Boma Mijan , (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk. are produced before this Court from the J.C. in physical mode.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) on Court bail are present before this Court by filing hazira.

One unfit certification in respect of the accused person namely (A-12) Abdul Karim @ Karim Sk. @ Iqbal along with a forwarding letter bearing no.12251/AB dated 13.11.2025 has been received from the Superintendent of Presidency Correction Home praying for production of this accused person through video conferencing operator, Presidency Correctional Home before this Court.

Perused the same and let the same be kept with the record.

Ld. Counsels for the accused persons are present.

Ld. Special P. P. is present by filing hazira.

At the time of calling out the name of the accused persons, it is submitted by one Presidency Correctional Home personnel namely Krishnendu Pandit from the Presidency Correctional Home that the accused person namely (A-12) Abdul Karim @ Karim Sk. @ Iqbal has been produced before this Court in physical mode, though there was a report from the Superintendent of Presidency Correction Home seeking permission to produce the said accused person through video conferencing operator, Presidency Correctional Home due to medical ground and thereafter the accused person was produced before this Court in virtual mode and thus, the said Presidency Correctional Home personnel namely Krishnendu Pandit misleads this Court.

In view of the above fact, the Superintendent of Presidency Correction Home is directed to take necessary action against the said Presidency Correctional Home personnel namely Krishnendu Pandit and submit a report in this regard by the next date fixed positively.

Now, the record is taken up for recording of evidence in presence of all sides.

P.W.2 namely, **Bikash Minj** is further examined in chief **in full** and thereafter he is cross-examined by the Ld. Counsel for the accused persons **in part**.

The original and certified copy of the GDE being STF PS GDE no.11 dated 01.02.2018 simultaneously are marked as **Exhibit-P-4/P.W.2 (with objection)** and the original and certified copy of the GDE being STF PS GDE no.54 dated 03.02.2018 simultaneously are marked as **Exhibit-P-5/P.W.2**.

Further cross-examination of P.W.2 namely Bikash Minj is deferred on the prayer of the Ld. Counsel for the accused persons.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W.2 dated 13.11.2025 is handed over to both sides i.e. the prosecution as well as the Ld. defence Counsel after obtaining endorsement in the relevant register.

A petition has been filed on behalf of the Ld. Special Public Prosecutor stating that the G.D. book (Vol.2/2018 from 24.01.2018 to 13.02.2018) contains the original G.D. entries bearing the STF PS General Diary Entry nos.11 dated 01.02.2018 and no.54 dated 03.02.2018 and the said original and certified copies of the STF PS General Diary Entry nos.11 dated 01.02.2018 and no.54 dated 03.02.2018 simultaneously have been marked as **Exhibit P-4/PW-2 (with objection)** and **Exhibit P-5/PW-2** respectively and prayed for returning the original G.D. book on the ground stated therein.

Heard the Ld. Special P.P.

Prayer is considered and allowed.

Let the original G.D. book (Vol.2/2018 from 24.01.2018 to 13.02.2018) containing the original G.D. entry bearing the STF PS General Diary Entry nos.11 dated 01.02.2018 and no.54 dated 03.02.2018 which have been marked as Exhibit-P-4/P.W.-2 (With objection) and Exhibit-P-5/P.W.2 be returned to the Prosecution under proper receipt after keeping the certified copy of the said original G.D. entry bearing the STF PS General Diary Entry nos.11 dated 01.02.2018 and no.54 dated 03.02.2018 with the case record with a direction to produce the same before this Court as and when called for.

Fixing **11.12.2025** for appearance and production of the accused persons and further cross-examination in chief of P.W.-2 and submission of report by the Superintendent of Presidency Correctional Home

Issue summons accordingly.

Requisites at once.

The accused person nos. (A-7), (A-10), (A-11), (A-12) and (A-13) are remanded to J.C. till 11.12.2025.

The accused person nos.(A-8), (A-14), (A-15) and (A-20) are as before.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary compliance.
