1. Today is fixed for appearance and production of the accused persons and further cross-examination of PW2 and submission of report by the Superintendent, Presidency Correctional Home.
2. The accused person nos.(A-7) Dilwar Hosssain @ Umar @ Nurul@ Ali Hassan, (A-10) Jahidul Islam @ Kausar @ Boma Mijan , (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil, (A-12) Abdul Karim @ Karim Sk. @ Iqbalis and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk. are produced before this Court from the J.C. in physical mode.
3. The accused person nos.(A-14) and (A-20) on Court bail are present before this Court.
4. Accused nos. 8 and 15 are absent and represented by a petition under section 317 of the Cr.P.C.
5. Heard. Considered. The prayer is allowed. The accused nos. 8 and 15 are permitted to represent through their Ld. Advocates under section 317 of the Cr.P.C.
6. PW2, namely Bikash Minj is further cross-examined by the Ld. Counsels for all the accused persons and he is discharged.
7. One compliance report has been received from the Superintendent, Presidency Correctional Home in compliance with order no. 142 dated 13.11.2025 passed by this Court.
8. Perused the same and let the same be kept with the record.
9. One petition has been filed on behalf of accused Jahidul Islam @ Kausar @ Boma Mijan.
10. By filing this petition, Ld. Advocate for this accused states that some individuals are trying to assault him and his life is at a stake. He further submits that on 06.12.2025 some individuals stored brick bats within the cell and threatened accused Jahidul Islam @ Kausar @ Boma Mijan with a dire consequence as he is a Bangladeshi National.
11. Under the canopy of the circumstances, the Superintendent of Dum Dum Correctional Home is directed to take necessary measures for safety and security of the accused Jahidul Islam @ Kausar @ Boma Mijan who is in the Dum Dum Correctional Home.
12. The Superintendent of Dum Dum Correctional Home is further directed to submit a report before this Court within **18.12.2025** positively.
13. Let a copy of this order be sent to the Superintendent of Dum Dum Correctional Home for information and necessary compliance.
14. The accused person nos.(A-7) Dilwar Hosssain @ Umar @ Nurul@ Ali Hassan, (A-10) Jahidul Islam @ Kausar @ Boma Mijan , (A-11) Mustafijur Rahaman @ Tuhin @ Sahin @ Shakil, (A-12) Abdul Karim @ Karim Sk. @ Iqbalis and (A-13) Adil Sk. @ Abdullah @ Assadulla @ Ajit Sk be remanded to J.C till 15.01.2026.
15. Fix **15.01.2026** for production & appearance of the accused persons and recording evidence of CSW6.
16. Accused persons, on bail, are as before.
17. Issue summons accordingly.
18. Put requisites at once.
