AWARD

The dispute between the parties having been referred for determination to the National Lok Adalat and the parties having compromised/settled the case/matter and made statements in Pre-Lok Adalat on 29.03.2023. The following Award is passed in the terms of the settlement:

Defendant has effected compromise with the plaintiff for an amount of Rs.3,04,000/-. He has seen pronote and receipt dated 25.06.2021 in the judicial file and he agreed that he duly executed the same in favour of the plaintiff in the presence of marginal witnesses and he identify his signature on the same. He is a government employee in Punjab Armed Police, 7 Batalian JRC, no.7/208 S at Jalandhar. His drawing and disbursing authority is Commandant 7 Batalian Punjab Armed Police Jalandhar City. He has no objection if an amount of Rs.8,000/- per month (38 installments) may be deducted

from his salary account and credited in the account of Plaintiff bearing A/c No.00741000928610, Punjab and Sind Bank, Jhoke Road, Ferozepur Cantt, District Ferozepur IFSC Code PSIB0000074 till the realization of Rs.3,04,000/-. In case any mis-happening with him or he can voluntarily retirement the remaining amount will be deducted from his service/retrial benefits. He shall be bound by his statement.

In case defendant fails to pay the settled amount as per the terms agreed upon in his statement dated 29.03.2023, plaintiff shall be at liberty to file execution for the amount of Award as per law. Award is accordingly passed. File be again put up for consignment and for refund the court fee.
