Today is fixed for production and appearance of the accused persons and evidence of prosecution witness.

The accused person no.1) namely Sanjib Das is produced from J.C. in virtual mode.

Ld. Counsel appointed from the LADCS, Kolkata for the accused person no.1) namely Sanjib Das is present by filing hazira along with an Assignment bearing no.943/LADCS-KOL/2025 dated 20.02.2025.

Let the same be kept with the record.

Accused person no. 2 namely Rajesh Sk on Court Bail is present before this Court by filing hazira.

Ld. Counsel for the accused persons and the Ld. P. Ps.-in-charge are present.

The accused person no.1) namely Sanjib Das is identified by the concerned Jail Authority and he expressed before this Court that he could see and hear the entire court proceedings without any technical glitch.

Ld. Counsel appointed from the LADCS, Kolkata for the accused person no.1) namely Sanjib Das files one bail application praying for enlarging the accused/petitioner on bail on any terms and condition on the ground stated therein.

Let the same be kept with the record.

No witness has turned up today.

Received one report from the Hastings Police Station duly forwarded by the O/C, Hastings Police Station stating that the Summon to witness namely Esmatora Bibi could not be served as the summonee was not found at the given address and it is known from the local people that the witness/summonee does not stay at the said address since last 2 years.

Perused the same and let the same be kept with the record.

A petition has been filed on behalf of the Prosecution stating that the summon could not be served upon the witness as the said witness could not be found at the given address and therefore an adjournment has been prayed for.

On perusal of the case record, it transpires that no witness turned up on 19.11.2024, 16.12.2024 and 27.01.2025 and today also no witness has turned up.

Having heard the submissions of both sides on the point of an adjournment, prayer for an adjournment is considered and allowed with a direction upon the I.O. of this case to take necessary steps to ensure attendance of the witness on the next date fixed positively.

The O/C, Hastings P.S. is also directed to look into the mater personally to ensure attendance of the witness on the next dates fixed positively.

Fix **12.03.2025** for hearing of the bail application dated 06.03.2025 filed on behalf of the accused person namely Sanjib Das.

Written objection, if any, in the meantime.

The I.O. of this case is directed to take necessary steps to ensure production of the C.D. on the next date fixed.

On submission of both sides, fix **10.04.2025** for production and appearance of the accused persons and evidence of prosecution witness.

Issue summons at once.

Requisites at once.

The accused person no. 1 namely Sanjib Das is remanded to J.C till 10.04.2025.

The accused person no. 2 namely Rajesh Sk as before.
