Order no. 34 dated 16.04.2026

1. Today is fixed for production of the accused person, appearance, hearing of the petition dated 06.04.2026 filed on behalf of the accused persons, written objection, if any, in the meantime and hearing on the point of cognizance.
2. Accused person, namely, Harish Bagla is produced before this Court from J.C through audio-video electronic means.
3. Ld. Special Public Prosecutor for the Enforcement Directorate is present.
4. Ld. Advocate for the accused person is present.
5. Hazira has been filed on behalf of the proposed accused/company no.21.
6. No step has been taken on behalf of the proposed accused/company nos.1 and 2.
7. A petition has been filed on behalf of the proposed accused/company nos.5, 6, 8, 9, 11, 14, 17, 19, 20, 23, 24 and 26 praying for condoning their absence on the ground stated therein.
8. Separate petitions have been filed on behalf of the proposed accused nos.22 and 25 praying for allowing them to be represented under section 317 of the Cr. P.C. read with section 355 of B.N.S.S. through their respective Ld. Counsels.
9. One petition has been filed on behalf of the proposed accused/company no.18 praying for allowing to be represented through the Ld. Counsel.
10. Heard both sides. Considered.
11. Prayers are allowed for the ends of justice.
12. Separate petitions along with server copy of order dated 06.04.2026 passed by the Hon'ble High Court at Calcutta in connection with CRR 1491 of 2026 have been filed on behalf of the proposed accused/company nos.3, 4, 7, 10, 12, 13, 15, 16 and 20 stating that the Hon'ble Court has been pleased to grant liberty to pray for an adjournment today and therefore Ld. Counsels have prayed for an adjournment.
13. Perused the copy of order wherein the Hon'ble Court has been pleased to observe as follows:
*"Let the matter appear in the Monthly list of May, 2026 under the heading "Contested Application".
Petitioner will be at liberty to pray for an accommodation before the Court below on 16th April, 2026."*
14. Ld. Special Public Prosecutor has filed a petition praying for judicial custody of the accused person, namely, Harish Bagla.
15. Heard. Perused the case record. Considered.
16. The prayer made by the Enforcement Directorate is allowed
17. In view of the above fact and circumstances, fix **30.04.2026** for production of the accused person.
18. Fix **15.05.2026** for appearance, hearing of the petition dated 06.04.2026 filed on behalf of the accused persons, written objection, if any, in the meantime and hearing on the point of cognizance.
19. The accused person namely Harish Bagla is remanded to J.C. till 30.04.2026.
20. Let a copy of this order be sent to the complainant/ED through the Ld. Special Public Prosecutor.
