Order No. 12 dated 23.06.2022

Today is fixed for production of the accused person **Namit Singh**, submission of I.O's report in final form and hearing bail petition dated **20.06.2022** in respect of accused **Namit Singh**.

Accused person namely, **Namit Singh** is produced from J.C.

Ld. Spl. P.P of NIA and Ld. Advocate for the accused person is present.

Ld. Spl. P.P of NIA files written objection and also files a petition praying for judicial custody of this accused person.

Let those be kept with the record.

I.O is present along with C.D.

Now the bail petition dated **20.06.2022** in respect of accused **Namit Singh** is taken up for hearing.

Ld. Advocate for this accused submits that this accused person is in custody since 12.05.2022 and the allegation against this accused/petitioner is totally false and this accused/petitioner has been falsely implicated due to political rivalry.

Ld. Advocate for this accused further submits that this accused person was arrested by the NIA in another case but was released as there was no prima facie of commission of offence committed by this accused person and only due to political rivalry this accused person was arrested.

Ld. Advocate for the accused person further submits that this accused person has fixed place of residence and there is no chance of his absconsion and the bail petition of this accused was rejected considering the initial stage of investigation but investigation has fairly progressed and he prays for bail on any terms and conditions.

Ld. Spl. P.P of NIA vehemently objected the bail petition of this accused and submits that allegation against this accused is serious in nature and 44 number of live bombs have been recovered which were concealed by this accused person and moreover the bail prayer of this accused was rejected by this court on earlier occasion and the investigation is at a primary stage and he prays for rejection of bail.

Heard both sides.

Perused the C.D and the materials on record wherefrom it reveals that this accused person was arrested on 12.05.2022 and it is also fact that 44 numbers of live bombs, one fire arms have already been recovered from a house where the accused had concealed the same.

It also reveals from the case record that the bail prayer of this accused has already rejected on 17.05.2022 considering the allegation against him is serious in nature but after that there is no change of circumstances to grant bail to this accused at this stage and investigation is at a nascent stage.

Considering all these and also considering the nature and gravity of the offence, the prayer for bail in respect of accused **Namit Singh** stands **rejected** at this stage.

Accused **Namit Singh** be remanded to J.C **till 06.07.2022**.

C.D be returned.

To **06.07.2022** for production of accused **Namit Singh** before this Court.
