To-day is fixed for evidence of Prosecution witnesses.

The accused person namely Namit Singh on interim bail is found absent on calls.

Ld. Counsel for the accused person and Ld. Special P.P. of NIA are present.

The accused person namely Namit Singh on interim Bail is absent by a petition and prays for representation of the accused person u/s 317 of Cr. P.C. through Ld. Counsel on the ground of demise of the accused person's uncle.

Heard both sides on the point of representation of the accused person u/s 317 of Cr. P.C. through Ld. Counsel.

Prayer is considered and allowed with a direction upon the above named accused person to remain present before this Court on the date fixed positively.

The accused person is allowed to be represented u/s 317 of Cr. P.C. through Ld. Counsel.

Witness namely Bipen Tamang is present before this Court.

In presence of both sides, the record is taken up for recording evidence. At this juncture, a petition has been filed on behalf of the accused person praying for an adjournment on the ground of unavailability of some documents and without which the cross-examination of the witness can not be done properly by the Ld. Defence Counsel and the accused person will be severely prejudiced.

Heard both sides on the point of adjournment.

In view of the submission of the Ld. Counsel for the accused person that the accused person will get prejudiced, prayer for adjournment is considered and allowed with a direction upon the Prosecution/NIA to supply copies of charge sheets and other documents, if any, to the accused persons as per prayer of the accused person in the meantime.

Another petition has been filed on behalf of the accused person praying for extension of the interim bail of the accused person on the ground stated therein.

No objection is raised to the extension of the interim bail of the accused person by the Ld. Special P.P. of NIA.

Heard both sides. Prayer for extension of the interim bail of the accused person is considered and allowed.

Witness namely Bipen Tamang is released today without examination.

Fix **06.02.2024** for evidence of Prosecution witnesses.

Issue fresh summons at once.

Requisites at once.

The accused person on interim bail is as before.

Interim bail of the accused person is extended till next date.

Let a copy of this order be sent to the I.O. of this case for information and necessary action.
