Order no.09 dated 29.08.2024

To-day is fixed for appearance of the accused person, hearing of the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh and further examination in chief of P.W.1 namely Bipen Tamang.

The accused person namely Namit Singh on interim bail is present by filing hazira. Ld. Counsel for the accused person and the Ld. Special P.P. of NIA are present.

P.W.1 namely Bipen Tamang is present before this Court. In presence of both sides the record is taken up for recording evidence. He is further examined in chief **in part.**

The Seizure list dated 12.03.2022 is proved and marked as **Exhibit-P-1/P.W.1**, the signature with date of witness, P.W.1 in the seizure list dated 12.03.2022 is proved and marked as **Exhibit-P-1/1/P.W.1**, the Seizure list dated 12.03.2022 prepared in between 15:55 hrs. to 16:25 hrs. is proved and marked as **Exhibit-P-2/P.W.1** and the signature with date of witness, P.W.1 in the seizure list dated 12.03.2022 prepared in between 15:55 hrs. to 16:25 hrs. is proved and marked as **Exhibit-P-2/1/P.W.1.**

Further examination in chief of P.W.1 namely Bipen Tamang is deferred on the prayer of the Ld. Special P.P. of NIA.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W-1 dated 29.08.2024 is handed over to both sides i.e. the Prosecution as well as the Ld. Defence Counsel after obtaining endorsement in the relevant register.

Now, the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh is taken up for hearing.

At this juncture, another petition has been filed on behalf of the Prosecution/NIA praying for an adjournment on the ground stated therein.

Heard both sides on the point of adjournment.

Prayer for adjournment is considered and allowed.

A petition has been filed on behalf of the accused person praying for extension of the interim bail of the accused person on the ground stated therein.

Heard both sides on the point of extension of the interim bail of the accused person.

Prayer for extension of the interim bail of the accused person is considered and allowed.

Fix **06.11.2024** for appearance of the accused person, hearing of the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh and further examination in chief of P.W.1 namely Bipen Tamang.
