Order no.10 dated 06.11.2024

To-day is fixed for appearance of the accused person, hearing of the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh and further examination in chief of P.W.1 namely Bipen Tamang.

The accused person namely Namit Singh on interim bail is found absent on calls.

Ld. Counsel for the accused person and the Ld. Special P.P. of NIA are present.

A petition has been filed on behalf of the accused person namely Namit Singh stating that the accused/petitioner is unable to attend Court today on account of Chatt Puja and therefore Ld. Counsel prays for condoning his absence with a further prayer to allow the accused person to be represented u/s 317 of Cr. P.C. through the Ld. Counsel.

Heard both sides on the point of representation of the accused person u/s 317 of Cr. P.C. through the Ld. Counsel.

Prayer for representation of the accused person u/s 317 of Cr. P.C. through the Ld. Counsel is considered and allowed today with a direction upon the accused person to remain present before this Court on the next date fixed positively.

No witness is present today.

A petition has been filed on behalf of the Prosecution/NIA stating that P.W.1 namely Bipen Tamang is unable to attend Court today and therefore an adjournment has been prayed for.

Having heard the submissions of both sides and also on consideration of the absence of the accused person, prayer for an adjournment is considered and allowed with a direction upon the Prosecution/NIA to take necessary steps to ensure attendance of the witness on the next date fixed positively.

Now, the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh is taken up for hearing.

At this juncture, another petition has been filed on behalf of the Prosecution/NIA stating that the accused person is co-operating with the investigation agency at this stage and appearing as and when called for by the I.O. in compliance with the order of bail and therefore Ld. Special P.P. prays for keeping the hearing of the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh in abeyance.

Heard both sides on the point of keeping the hearing of the petition dated 29.06.2024 in abeyance.

In view of the above fact, hearing of the petition dated 29.06.2024 filed on behalf of the Prosecution/NIA praying for cancellation of the bail of the accused person namely Namit Singh is kept in abeyance as per the prayer of the Prosecution/NIA.

Another petition has been filed on behalf of the accused person praying for extension of the interim bail of the accused person on the ground stated therein.

Heard both sides on the point of extension of the interim bail of the accused person.

Prayer for extension of the interim bail of the accused person is considered and allowed with a direction upon the accused person to remain present before this Court on the next date fixed.

Fix **11.12.2024** for appearance of the accused person and further examination in chief of P.W.1 namely Bipen Tamang.

Issue fresh summons at once.

Requisites at once.

The accused person on interim bail is as before.

Interim bail of the accused person is extended till next date.
