The signature of P.W.1 on the label pasted on the tin box is marked as **Material Exhibit-P-I/P.W.1**, the tin box is marked as **Material Exhibit-P-II/P.W.1**, the signature of P.W.1 on the label pasted on another tin box is marked as **Material Exhibit-P-III/P.W.1** and another tin box is marked as **Material Exhibit-P-IV/P.W.1**.

Further examination in chief of P.W.1 namely Bipen Tamang is deferred on the prayer of the Ld. Special P.P. of NIA.

As per the Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W.1 namely Bipen Tamang dated 07.07.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

A petition has been filed on behalf of the accused person praying for extension of the interim bail of the accused person on the ground stated therein.

Heard both sides.

Prayer for extension of the interim bail of the accused person is considered and allowed.

Fix **08.08.2025** for appearance of the accused person and further examination in chief of P.W.1 namely Bipen Tamang.
