**Order no. 21 dated 02.02.2026**

1. Today is fixed for appearance of the accused person and further examination of PW-1 Bipen Tamang.
2. Accused Namit Singh, on interim bail, is absent and being represented by filing petition u/s 317 of the Cr.P.C.
3. Ld. Special Public Prosecutor for the NIA and Ld. Advocate for the accused are present today.
4. PW-1 Bipen Tamang is present before this Court.
5. Now, the record is taken up for recording evidence.
6. PW-1 is examined in chief by the Ld. Special Public Prosecutor in part.
7. Examination in chief of PW-1 is deferred on prayer of the Ld. Special Public Prosecutor.
8. During the course of examination, the certified copy of General Diary Entry no. 814 dated 12.03.2022 is marked as X for identification, the label pasted on the envelope is marked as Mat Exhibit P-V/PW-1, the signature of PW-1 on the label pasted on the envelope is marked as Mat Exhibit P-V/1/PW-1, the lock is marked as Mat Exhibit P-VI/PW-1 (with objection), one tape is marked as Mat Exhibit P-VII/PW-1 (with objection), the label pasted on this envelope is marked as Mat Exhibit P-VIII/PW-1, the signature of PW-1 on the label pasted on the envelope is marked as Mat Exhibit P-VIII/1/PW-1, the 08 adhesive tapes are marked as Mat Exhibit P-IX/PW-1 collectively (with objection), the label is marked as Mat Exhibit P-X/PW-1, the signature on the label pasted on the envelope is marked as Mat Exhibit P-X/1/PW-1, the label is marked as Mat Exhibit P-XII/PW-1, the signature of PW-1 on the label pasted on the envelope is marked as Mat Exhibit P-XII/1/PW-1, the one round live like ammunition which was loaded in the country made improvised revolver is marked as Mat Exhibit P-XIII/PW-1 (with objection), the label is marked as Mat Exhibit P-XIV/PW-1, the signature of PW-1 on the label pasted is marked as Mat Exhibit P-XIV/1/PW-1 and the plastic box is marked as Mat Exhibit P-XV/PW-1 (with objection).
9. As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of PW-1 dated 02.02.2026 is handed over to all sides after obtaining endorsement in the relevant register.
10. Reissue summons accordingly.
11. One petition has been filed on behalf of the accused praying for extension of the interim bail of the accused.

14. Fix **05.03.2026** for appearance of the accused person and further examination in chief of PW-12.
15. Interim bail of the accused be extended till 05.03.2026.
