**Order no. 22 dated 14.11.2022**

To-day is fixed for inspection of copy of charge sheet by accused person prior to hearing of consideration of charge and hearing of the petition dated 28.10.2022 filed on behalf of the accused namely **Namit Singh** for waiving the conditions as per order dated 16.08.2022.

The accused person namely **Namit Singh** is on interim bail and is found present in Court by filing hazira along with Ld. Advocate.

Ld. Special P.P. of NIA is present.

One petition has been filed on behalf of the accused person stating that the Ld. Senior Advocate could not complete inspection of the copy of the charge sheet and prayed for an adjournment to that effect.

Heard both sides.

Prayer is considered and allowed.

The petition dated 28.10.2022 filed on behalf of the accused namely **Namit Singh** for waiving the conditions as per order dated 16.08.2022 is taken up for hearing.

Ld. Advocate for the accused person submits before this Court that the accused has complied order dated 16.08.2022 and also order dated 28.10.2022 passed by this Court respectively and there is no adverse report against the accused person and prays for passing order for waiving conditions imposed upon the accused person vide order dated 16.08.2022.

Ld. Special P.P. of NIA though opposed the prayer, but left the matter on the discretion of this Court.

Having heard both sides and also perusing the material on record this Court finds that there is no adverse report against the accused persons after his release on interim bail.

Considering all these, the order no.18 dated 16.08.2022 is modified to the extent that

- i) The accused **Namit Singh** is directed to meet with the I.O. of this case **once in a month** instead of once in a week until further order;
- ii) The accused **Namit Singh** is at liberty to leave the jurisdiction of Calcutta, but that too after two months from the date of passing of this order, but the accused is directed not to leave the jurisdiction of West Bengal without prior permission of the Ld. Court.

**Continued order 22 dated 14.11.2022**

The rest portion of the order dated 16.08.2022 will remain the same.

Fix **14.12.2022** for inspection of copy of charge sheet by accused person prior to hearing of consideration of charge.

To-date i.e. **14.12.2022** for appearance of the accused, **Namit Singh** on interim bail.

Interim bail granted to the accused person by this Court is hereby extended till next date i.e. 14.12.2022 for the ends of justice.
