Order no.07 dated 04.06.2026

1. Today is fixed for production of the accused persons from the J/C.
2. Accused persons, namely, Akramul Bagani and Mofakkerul Islam are produced through audio video electronic means before this Court from J/C.
3. Ld. Special Public Prosecutor representing the NIA is present.
4. Ld. Advocates for accused persons are present today.
5. Ld. Special Public Prosecutor for NIA files a petition praying for further judicial custody of both the accused persons.
6. Heard. Considered. Prayer stands allowed for proper investigation of this case.
7. At this juncture, Ld. Special Public Prosecutor for NIA submits that this Court was pleased to direct the Ld. Chief Judicial Magistrate, Calcutta to take necessary steps to record statement of accused Mofakkerul Islam, but statement could not be recorded due to non production of the accused.
8. In view of such fact, Ld. Chief Judicial Magistrate, Calcutta is again directed to take necessary steps to record statement of accused Mofakkerul Islam on 08.06.2026 maintaining the guidelines and also directed to forward a copy of the statement of the said accused before this Court.
9. The Investigating Officer is directed to take necessary steps for production of the accused Mofakkerul Islam before the concerned Ld. Magistrate, Calcutta on the stipulated time and date for recording statement under section 183 of BNSS, 2023.
10. The Superintendent of Presidency Correctional Home is also directed to take necessary steps for production of the accused Mofakkerul Islam before the concerned Ld. Magistrate, Calcutta on 08.06.2026 for recording statement under section 183 of BNSS, 2023.
11. The accused persons, namely, Akramul Bagani and Mofakkerul Islam be remanded to J.C. till 18.06.2026.
12. To **18.06.2026** for production of the accused persons from the J/C.
13. Let a copy of this order be sent to the Ld. Chief Judicial Magistrate, Calcutta for information.

14. Let a copy of this order be sent to the Superintendent, Presidency Correctional Home for information and rendering all possible assistance to the I.O in this regard.

15. Let a copy of this order be sent to the Investigating Officer through the Ld. Special Public Prosecutor for information.
