The accused person namely Jayeeta Das has not been produced before this Court in terms of order no.45 dated 26.06.2023 passed by the Ld. Judge, Bench-II, City Sessions Court, Calcutta either in physical mode or in virtual mode.

No report is received in this regard.

Ld. Advocates for the accused persons as well as Ld. Special P.P. is present.

Heard both sides.

Perused the case record wherefrom it reveals to this Court that date was fixed for production of the accused who is on Court bail in this case, but in custody in another case and for further evidence of P.W.-1 before the Ld. Transferee Court. Hence, the case be proceeded with from that part where it had ended before my Coordinate Bench i.e. the Court of Ld. Judge, Bench-II, City Sessions Court, Calcutta.

Fix **08.08.2023** for production of the sole accused person who is on C.B. in this case either in physical mode or in virtual mode and further evidence of P.W.-1.
