Today is fixed for production of the sole accused person who is on C.B. in this case either in physical mode or in virtual mode and hearing of the petition dated 25.09.2023 filed on behalf of the accused person praying for dropping the proceedings of the instant case in view of the Judgment and decisions passed by the Hon'ble Supreme Court of India in Bikramjit Singh's case (2022(10) SCC 616) and filing fresh petition, if any.

The Accused no.(A-1), Jayeeta Das @ Rumpa is produced before this Court from J.C. in virtual mode.

Received one report from the Superintendent of Alipore Women's Correctional Home communicated vide office letter no.1997/AB dated 08.05.2024 regarding non production of the Accused no.(A-1), Jayeeta Das @ Rumpa before this Court in physical mode.

As the Accused no.(A-1), Jayeeta Das @ Rumpa is produced before this Court from J.C. in virtual mode, let the same be kept with the record.

The Accused no.(A-1), Jayeeta Das @ Rumpa is identified by the Jail Authority and she expressed that she could see and hear the entire court proceedings without any technical glitch.

Ld. Counsel for the accused person and the Ld. Special P. Ps. are present today.

The petition dated 25.09.2023 filed on behalf of the accused person prayed for dropping the proceedings of the instant case in view of the Judgment passed by the Hon'ble Supreme Court of India in Bikramjit Singh's case (2022(10) SCC 616) is taken up for hearing.

At this juncture, a petition has been filed by the Ld. Counsel for the accused person stating that conducting Ld. Counsel is unable to attend Court physically or virtually due to some personal reasons of the Ld. Counsel and therefore an adjournment has been sought for.

A petition has been filed on behalf of the Prosecution stating that conducting Ld. Special P.P. is unable to attend Court today due to his illness and therefore an adjournment has been prayed for.

Heard both sides on the point of adjournment.

Having heard the submissions of both sides and also on consideration of the resolution "Not to pass any adverse order" taken by local Bar, prayer for adjournment is allowed on consent.

The Superintendent of Alipore Women's Correctional Home is directed to ensure production of the Accused no.(A-1), Jayeeta Das @ Rumpa before this Court on the next date fixed.
