5. Perused the same and let the same be kept with the record.
6. Ld. Counsel for the accused person is present.
7. Ld. Special P.P. is present.
8. No witness has turned up today.
9. A petition has been filed on behalf of the prosecution stating that the witness is unable to attend Court today due to his illness and therefore an adjournment has been prayed for.
10. Heard both sides.
11. Prayer for an adjournment is considered and allowed with a direction upon the Prosecution to take necessary steps to ensure attendance of the witness on the next date fixed positively.
12. The Superintendent of Alipore Women's Correctional Home is directed to take necessary steps to ensure production of the accused person namely Jayeeta Das @ Rumpa before this Court on the next date fixed positively.
13. Fix **10.04.2026** for production of the sole accused person who is on C.B. in this case and further examination of P.W.2.

14. Issue summons accordingly.

15. Requisites at once.

16. The accused person is as before.

17. Let a copy of this order be sent to the Superintendent of Alipore Women's Correctional Home for information and necessary compliance.
