Received one copy of report from the Superintendent of Presidency Correctional Home, Alipore, Kolkata-27 vide letter no.1947/AB dated 09.02.2025 with regard to production of the accused person in virtual mode.

The sole Accused person namely Sumit Kumar Shaw @ Jadu is not produced before this Court from the J.C. either in physical mode or in virtual mode.

It is submitted by the System Officer of this Court that due to some technical glitch the concerned Correctional Home Authorities could not be connected through the virtual mode.

Received one report from the Superintendent of Presidency Correctional Home vide letter no.1990/AB dated 10.02.2025 stating that the accused person namely Sumit Kumar Shaw @ Jadu could not be produced before this Court in virtual mode due to network issue.

Let the same be kept with the record.

Ld. Counsel for the accused person and the Ld. P. Ps.-in-charge are present.

The photographer, Biren Roy Chowdhury is present before this Court.

In view of the non production of the accused person namely Sumit Kumar Shaw @ Jadu before this Court from the J.C. either in physical mode or in virtual mode, this Court has no other alternative but to adjourn the matter today.

Accordingly, the case is adjourned today for the ends of justice.

The photographer, Biren Roy Chowdhury is released today without examination.

On submissions of both sides, fix **15.02.2025** for production of the accused person either in physical mode or in virtual mode and evidence of the photographer, Biren Roy Chowdhury.

Re-issue the summon in the name of the photographer, Biren Roy Chowdhury with a direction to remain present before this Court on the next date fixed for adducing evidence.

The Accused person is remanded to J.C. till 15.02.2025.

Let a copy of this order be sent to the Superintendent of Presidency Correctional Home for information and necessary action.
