Today is fixed for production of the accused person either in physical mode or in virtual mode and evidence of the photographer, Biren Roy Chowdhury.

The sole Accused person namely Sumit Kumar Shaw @ Jadu is produced before this Court from the J.C. in physical.

Ld. Counsel for the accused person and the Ld. P. Ps.-in-charge are present.

The photographer, Biren Roy Chowdhury is present before this Court.

In presence of both sides and on consent of both sides the record is taken up for recording of evidence.

The photographer, Biren Roy Chowdhury is examined in chief as **P.W.3 in full** on behalf of the Prosecution and thereafter he is cross-examined by the Ld. Counsel for the accused person **in part**.

The twenty two (22) photographs clicked on the footpath in front of premises at 39, Chitta Ranjan Avenue, Kolkata-12 on 27.03.2024 are proved and marked as **Exhibit-P-4/P.W.3 (Collectively)**, the two photographs clicked at Kolkata Police Morgue, Kolkata Medical College Hospital on 27.03.2024 are proved and marked as **Exhibit-P-5/P.W.3 (Collectively)** and the 8 GB master micro SD card being no.4711425040088 is proved and marked as **Exhibit-P-6/P.W.3**.

Further cross-examination of **P.W.3** namely Biren Roy Chowdhury is deferred on the prayer of the Ld. Counsel for the accused person.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W-3 dated 15.02.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsel after obtaining endorsement in the relevant register.

On submissions of both sides, fix **13.03.2025** for production of the accused person either in physical mode or in virtual mode and further cross-examination of P.W.3, Biren Roy Chowdhury.

Re-issue the summon in the name of the P.W.3, Biren Roy Chowdhury with a direction to remain present before this Court on the next date fixed for adducing evidence.

The Accused person is remanded to J.C. till 13.03.2025.
