The Judicial case record being case no. Bhupatinagar P.S. case no. 463/22 dated 02.12.2022 (GR- 2624/22) in two files-“A” file and “B” file containing 132 pages in total is received from the Ld. District Medinipur, Purba Medinipur vide office letter no.1836/XI-6 dated 16.06.2023 in terms of order no.01 dated 05.06.2023 passed by this Court.

Perused the same.

Let the record of Bhupatinagar P.S. case no. 463/22 dated 02.12.2022 (GR- 2624/22) be kept with the record.

On perusal of the L.C.R. (Bhupatinagar P.S. case no. 463/22 dated 02.12.2022 (GR- 2624/22), this Court finds no order for transmission of the case record from Ld. District Judge, Purba Medinipur to this Court save and except the forwarding letter.

District & Sessions Judge, Tamluk, Purba Medinipur, West Bengal is further requested to direct the concerned Court for P.S.- Bhupatinagar to take necessary steps to ensure production of all the arrested accused persons, if any, and/or direct the Surety(s) to produce all the accused persons in connection with case being FIR no.463/2022 dated 02.12.2022 of P.S.- Bhupatinagar before the Court of Ld. Chief Judge, City Sessions Court, Calcutta, Bichar Bhawan, 2 & 3 Bankshall Street, Kolkata – 7 00 001 on the date fixed i.e.05.08.2023.

Fix **05.08.2023** for production of the Accused persons/production of the accused person or persons by the Surety (s) and further order.

Let a copy of this order along with a Letter of Request be forwarded to the Ld. District & Sessions Judge, Tamluk, Purba Medinipur, West Bengal for information and necessary action.

Let a copy of this order also be given to the C.I.O., NIA through Ld. Special P.P., NIA for information and necessary action.
