**Order no. 21 dated 18.04.2024**

Today is fixed for production of these two accused persons namely (i) **Manobrata Jana** and (ii) **Balai Charan Maity** before this Court from P.C and hearing of the bail petition dated 10.04.2024 filed by these two accused persons in person.

Today is also fixed for appearance of the accused person Panchanan Ghorai who is on Court bail, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) of Cr.P.C praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

Both the accused persons namely, (i) **Manobrata Jana** and (ii) **Balai Charan Maity** are produced from P.C before this Court along with medical documents.

Both the accused persons namely, (i) **Manobrata Jana** and (ii) **Balai Charan Maity** are taken into custody.

Accused person namely, **Panchanan Ghorai** who is on Court bail is present and he files hazira in person.

Neither the Ld. Spl. P.P of NIA nor the Ld. Counsels for the accused persons are present.

No steps is taken on behalf of the accused persons.

No steps is taken on behalf of the Ld. Spl. P.P of NIA.

I.O is present.

Dy S.P/CIO, NIA, B.O, Kolkata files a petition through the I.O of this case praying for fourteen days judicial custody of both the accused persons namely (i) **Manobrata Jana** and (ii) **Balai Charan Maity** in the interest of thorough and proper investigation of this case.

Now the record is taken up for hearing on the point of fourteen days judicial custody of these two accused persons (i) **Manobrata Jana** and (ii) **Balai Charan Maity** as prayed by the I.O of this case.

Neither the Ld. Spl. P.P of NIA nor the Ld. Counsels for the accused persons are present.

No steps is taken on behalf of the accused persons.

No steps is taken on behalf of the Ld. Spl. P.P of NIA.

Ld. Counsels for the LADCS, Kolkata present in Court is directed to take all steps at once on behalf of the accused persons so that the accused persons are not unrepresented.

I.O is present on dock and he prays for fourteen days judicial custody of these two accused persons (i) **Manobrata Jana** and (ii) **Balai Charan Maity** in the interest of thorough and proper investigation of this case.

Heard the I.O and Ld. Counsels, LADCS, Kolkata on behalf of the accused persons.

Perused the petition of the I.O and the case record.

On perusal of the case record I find that the investigation has revealed that the accused persons mentioned herein above took active steps for making of bombs and illegally procuring explosives to be used against the general public to terrorize the people at large.

Considering these facts and the nature and gravity of the offence alleged, the prayer of the I.O for fourteen days judicial custody of these two accused persons **(i) Manobrata Jana** and **(ii) Balai Charan Maity** is allowed.

These two accused persons these two accused persons **(i) Manobrata Jana** and **(ii) Balai Charan Maity** be remanded to J.C till **30.04.2024**.

No further order of the Hon'ble High Court at Calcutta has yet been filed by the accused person.

The petition dated 25.07.2023 u/s 439 (2) of Cr.P.C praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides is taken up for hearing.

At this stage, accused person Panchanan Ghorai files a petition in person praying for adjournment for hearing the petition dated 25.07.2023 u/s 439 (2) of Cr.P.C filed by the NIA for the ends of justice.

Now the bail petition dated 10.04.2024 filed by these two accused persons in person is taken up for hearing.

None moves the bail petition dated 10.04.2024 filed on behalf of these two accused persons.

I am of the view that one short date be fixed for hearing of the bail petition dated 10.04.2024 and an opportunity should be given to the Prosecution/NIA to file written objection, if any in the meantime.

In view of the resolution dated 15.04.2024 that **the General Members will abstain from judicial works** taken by the local bar, the case is adjourned for the ends of justice.

Fix **20.04.2024** for hearing of the bail petition dated 10.04.2024 on behalf of accused persons namely **(i) Manobrata Jana** and **(ii) Balai Charan Maity** and filing of written objection, if any, in the meantime by the prosecution/NIA.

Todate **30.04.2024** for production of these two accused persons namely **(i) Manobrata Jana** and **(ii) Balai Charan Maity** before this Court from J.C.

Todate i.e. **30.04.2024** for appearance of the accused person namely Panchanan Ghorai, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) of Cr.P.C praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

Let a copy of this order be sent to the I.O through Ld. Spl. P.P of NIA for information and necessary compliance.

Let a copy of this order be sent to the Ld. Counsels for the LADCS, Kolkata for information.
