Order No.05 dated 05.08.2022

To-day is fixed for production of the accused persons/production of the accused person or persons by the Surety (s) and hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

Neither the accused person namely Panchanan Ghorai is present before this Court, nor any step has yet been taken on behalf of the accused person.

Ld. Special P.P. of NIA is present in Court.

One petition has been filed on behalf of the Prosecution/NIA stating that copy of the petition dated 25.07.2023 could not be served upon the accused person due to non availability of address and contact number of the accused person and therefore it is prayed for a direction upon the accused person to be present before this Court on the next date fixed on the ground stated therein.

Heard the Ld. Special P.P. of NIA.

On perusal of the order no.02 dated 05.07.2023, it reveals that Ld. District & Sessions Judge, Purba Medinipur, West Bengal was requested to direct the concerned Court of P.S.-Bhupatinagar to take necessary steps to ensure production of the all the arrested accused persons, if any, and/or direct the Surety (s) to produce all the accused persons in connection with case being FIR no.463/2022 dated 02.12.2022 of P.S. Bhupatiganar before this Court.

No accused person (s) is/are produced before this Court, or present before this Court.

In view of such fact, Ld. District & Sessions Judge, Purba Medinipur, West Bengal is again requested to direct the concerned Court of P.S.-Bhupatinagar to take necessary steps to ensure production of the all the arrested accused persons, if any, and/or direct the Surety (s) to produce all the accused persons in connection with case being FIR no.463/2022 dated 02.12.2022 of P.S. Bhupatiganar before this Court on the next date fixed i.e.28.08.2023.

Prosecution/NIA is also directed to take all necessary measure for service of copy of the petition dated 25.07.2023 upon the accused person in the meantime.

Fix **28.08.2022** for production of the accused persons/production of the accused person or persons by the Surety (s) and hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.
