To-day is fixed for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

To-day is also fixed for production of the two accused persons namely (i) Manobrata Jana and (ii) Balai Charan Maity before this Court from J.C.

The accused persons namely i) Manobrata Jana and ii) Balai Charan Maity are produced before this Court from J.C.

The accused person namely Panchanan Ghorai on Court Bail is absent by filing a petition and prays for condoning his absence on the ground stated therein.

Ld. Counsels for the accused persons and the Ld. Special P.P. of NIA are present.

Having heard the Ld. Counsel for the accused person namely Panchanan Ghorai and also on consideration of the resolution "Not to pass any adverse order" taken by local Bar, prayer for condoning his absence is allowed with a direction to remain present on the next date fixed.

Received one copy of order dated 10.06.2024 passed by the Hon'ble Supreme Court of India in Petition (s) for Special Leave to Appeal (Crl.) Dy. S.P./CIO, NIA, B.O., Kolkata filed one petition through Ld. Special P.P. of NIA praying for further remanding the accused persons namely i) Manobrata Jana and ii) Balai Charan Maity to judicial custody for a period of fortnight in the interest of proper and thorough investigation.

The remand application filed today on behalf of the Prosecution/NIA is taken up for hearing.

Heard both sides.

Perused the petition of the I.O. and the materials on record.

Considering the submission of both sides and on perusal of the materials on record and considering the gravity of this case and being prima facie satisfied with the submission of Ld. Special P.P. of NIA that further investigation is going on with regard to the involvement of the accused persons in procuring explosives illegally and thus, the prayer for remanding the two accused persons to judicial custody is considered and allowed till 03.07.2024.

The petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA is taken up for further hearing in presence of both sides.

Heard the Ld. Special P.P. of NIA in part.

The accused persons namely i) Manobrata Jana and ii) Balai Charan Maity are remanded to J.C. till 03.07.2024.

Fix **20.06.2024** for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr.
