To-day is fixed for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

The accused person namely Panchanan Ghorai on Court Bail is absent by filing a petition and prays for condoning his absence with a further prayer to allow the Ld. Counsel to represent the accused person u/s 317 of Cr. P.C. on the ground stated therein.

Ld. Counsel for the accused person and the Ld. Special P.P. of NIA are present.

Having heard the Ld. Counsel for the accused person namely Panchanan Ghorai and also on consideration of the resolution "Not to pass any adverse order" taken by local Bar, prayer for condoning his absence is allowed with a direction to remain present on the next date fixed.

Ld. Counsel for the accused person namely Panchanan Ghorai is at liberty to represent the accused person u/s 317 of Cr. P.C.

Neither any further order of the Hon'ble High Court at Calcutta, nor any stay order of the Hon'ble Court has yet been furnished by the accused person namely Panchanan Ghorai.

The petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA is taken up for further hearing in presence of both sides.

At this juncture, a petition has been filed on behalf of the accused person namely Panchanan Ghorai stating that conducting Ld. Counsel is feeling unwell and therefore an adjournment has been prayed for.

Heard both sides on the point of adjournment.

Having heard the submissions of both sides and also on consideration of the resolution "Not to pass any adverse order" taken by local Bar, prayer for adjournment is allowed.

Fix **25.06.2024** for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

To-date i.e. on **03.07.2024** for production of the two accused persons namely (i) Manobrata Jana and (ii) Balai Charan Maity before this Court from J.C. and I.O's. report in final form.

The I.O. of this case is directed to take necessary steps to ensure production of the C.D. on the next date fixed.
