The accused persons namely i) Manobrata Jana and ii) Balai Charan Maity are produced before this Court from J.C.

Ld. Counsels for the accused persons and the Ld. Special P.P. of NIA are present.

Dy. S.P./CIO, NIA, B.O., Kolkata has filed one petition through Ld. Special P.P. of NIA praying for further remanding the accused persons namely i) Manobrata Jana and ii) Balai Charan Maity to judicial custody for a period of fortnight in the interest of proper and thorough investigation.

The remand application filed today on behalf of the Prosecution/NIA is taken up for hearing.

Heard both sides.

Perused the petition of the I.O. and the materials on record.

Considering the submission of both sides and on perusal of the materials on record and considering the gravity of this case and being prima facie satisfied with the submission of Ld. Special P.P. of NIA that the investigation is at nascent stage and further investigation is going on with regard to the involvement of the accused persons and thus, the prayer for remanding the two accused persons to judicial custody is considered and allowed till 16.07.2024.

The accused persons namely i) Manobrata Jana and ii) Balai Charan Maity are remanded to J.C. till 16.07.2024.

Fix **16.07.2024** for production of the two accused persons namely (i) Manobrata Jana and (ii) Balai Charan Maity before this Court from J.C. and I.O's. report in final form.

To-date i.e. on **09.07.2024** for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

Let a copy of this order be sent to the I.O. of this case through Ld. Special P.P. of NIA as prayed for.
