Today is fixed for production of the accused person from the J.C, appearance of the accused persons who are on bail and hearing of the bail application of the accused person Panchanan Ghorai and consideration of charge.

The accused person namely **Panchanan Ghorai** is produced before this Court from J.C.

Accused persons **Balai Charan Maity and Manobrata Jana** on Court bail are present before this Court by filing hazira.

Ld. Public Prosecutor and the Ld. Advocates for the accused persons are present.

Ld. Public Prosecutor opened the case by describing the charge brought against the accused persons and stating by what evidences he proposes to prove the guilt of the accused persons.

Thus, the case is taken up for consideration of charge.

Heard Ld. Public Prosecutor as well as the Ld. Advocate of the accused persons.

Considered.

Perused the materials on record. Prima facie case **under sections 120B and 436 of the Indian Penal Code** and **under sections 5 and 6 of the Explosive Substances Act** has been made out against the accused person namely **Panchanan Ghorai**.

Prima facie case under sections **120B, 201 and 436 of the Indian Penal Code** and **under sections 4 and 6 of the Explosive Substances Act** has been made out against the accused persons namely **Balai Charan Maity and Manobrata Jana**.

Accordingly, the contents of the charge was read over and explained to the accused persons to which they pleaded not guilty by saying "Nirdosh".

The charge is framed in a separate sheet and be kept with the record.

Fixing **03.06.2025** for evidence of prosecution witnesses, production of the accused person from the J.C, appearance of the accused persons who are on bail.

Prosecution is directed to take steps for production of witnesses on the next date fixed.

Now, the bail petition is taken up for hearing.

Bail petition has been filed on behalf of the accused Panchanan Ghorai.

Bail is moved on behalf of the accused Panchanan Ghorai.

Ld. Advocate for the accused Panchanan Ghorai prays for bail on the ground that this accused person is innocent and the allegations levelled against the accused is absolutely vague and improbable. He further submits that he is a resident within the jurisdictional limit of Bhupati Nagar P.S, District Purba Medinipore. He further submits that the accused is in custody for a considerable period of time. So, he prays for mercy of this Court.

Ld. Public Prosecutor opposes the prayer for bail of this accused person.

I have carefully perused the record and the submissions of both sides.

On careful perusal of the record as well as the charge sheet, I get to gather that prima facie involvement of this accused person is writ large all over the record.

Considering the gravity and enormity of the crime and the role of the accused in alleged offence, I do not find any just cause to allow the bail prayer of this accused person.

Accordingly, the bail prayer of the accused person namely **Panchanan Ghorai** stands **rejected**.
