To-day is fixed for appearance of the accused persons and evidence of C.S.W.44, Kajal Dutta.

The accused persons namely (i) Panchanan Ghorai, (ii) Manobrata Jana and (iii) Balai Charan Maity on Court bail are present before this Court by filing haziras.

Ld. Counsel for the accused persons and the Ld. Special P.P. of NIA are present.

C.S.W.44, Kajal Dutta is present before this Court. He is examined in chief as **P.W.2** in full, cross-examined by the Ld. Counsels for the accused persons **in full** and thereafter he is **discharged**.

The endorsement along with the signature of the witness on the written complaint is marked as **Exhibit-P-1/2/P.W.2**, the formal FIR is marked as **Exhibit-P-3/1/P.W.2**, the signature of the witness on the report of the Bomb Disposal Squad is marked as **Exhibit-P-4/P.W.2 (after objection)** and the signature of the witness on the another report of the Bomb Disposal Squad is marked as **Exhibit-P-5/P.W.2 (after objection)**.

As per Gazette Notification dated 15.07.2022, the certified true copies of the deposition of P.W. no.2 dated 10.09.2025 is handed over to both sides i.e. the prosecution as well as the Ld. Defence Counsels after obtaining endorsement in the relevant register.

A petition has been filed on behalf of the accused person namely (i) Panchanan Ghorai praying for extension of interim bail on the ground stated therein.

On perusal of the case record it transpires that this Court passed an order on 02.09.2025 to the effect that the interim bail granted to the accused Panchanan Ghora vide order no.09 dated 13.08.2025 be extended till 14.11.2025.

Accordingly, let the petition be kept with the record.

Ld. Special P.P. of NIA prays for issuance of summons upon the C.S.W.45.

Fixing **12.11.2025** for appearance of the accused persons and evidence of C.S.W.45.
