To-day is fixed for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

The accused person namely Panchanan Ghorai on Court Bail is present before this Court by filing hazira.

Prayer for time is considered and allowed for the ends of justice.

Insp./AIO, NIA, B.O., Kolkata has filed one petition through Ld. Special P.P. of NIA praying for some more time to complete the investigation and to file charge sheet.

Heard both sides. Prayer for time to file charge sheet is considered and allowed in the interest of proper investigation.

On submission of both sides, fix **04.03.2024** for appearance of the accused person, bringing order of the Hon'ble High Court at Calcutta, if any, and further hearing of the petition dated 25.07.2023 u/s 439 (2) Cr. P.C. praying for cancellation of bail of the accused person namely Panchanan Ghorai filed on behalf of the Prosecution/NIA in presence of both sides.

Let a copy of this order be sent to the I.O. of this case through Ld. Special P.P. of NIA with a direction to ensure production of the C.D. on the date fixed.
