1. Ld. P.O. has been retained on duty during the upcoming process of Special Intensive Revision (S.I.R.) by the Hon'ble Court, Calcutta in view of the order dated 20.02.2026 passed by the Hon'ble Supreme Court of India in Writ petition (s) Civil Number (s) 1089 of 2025 with W.P. (C) number-126/2026, W.P. (C) number-129/2026 (PIL-W), W.P. (C) number-737/2026 (PIL-W,), W.P. (C) number-1074/2026 (PIL-W), W.P. (C) number-1088/2026 (PIL-W), W.P. (C) number-1088/2026 (PIL-W), W.P. (C) number-1216/2026 (PIL-W), W.P. (C) number-159/2026 (PIL-W), W.P. (C) number-119/2026 (PIL-W) and Interlocutory applications listed therewith. I am in charge.
2. To-day is fixed for appearance of the accused persons and evidence of C.S.W.41 Sumita Bhattacharjee.
3. The accused persons namely (i) Panchanan Ghorai, (ii) Manobrata Jana and (iii) Balai Charan Maity on Court bail are present before this Court by filing haziras.
4. Ld. Counsels for the accused persons are present.
5. Ld. Special Public Prosecutor of NIA is present.
6. No witness has turned up today.
7. A petition has been filed on behalf of the Prosecution/NIA stating that C.S.W.41 is unable to attend Court today as he is busy with official work and therefore the Ld. Special P.P. for NIA prays for an adjournment.
8. Heard both sides.
9. Prayer for an adjournment is considered and allowed with a direction upon the Prosecution to take proper and necessary steps to ensure attendance of the C.S.W.41 on the next date fixed.
10. A petition has been filed on behalf of the accused person namely (i) Panchanan Ghorai praying for extension of interim bail on the ground stated therein.
11. Prayer for extension of interim bail is considered and allowed.
12. Accordingly, interim bail granted to the accused Panchanan Ghora vide order no.13.08.2025 passed by this Court is hereby extended till next date i.e. on 17.04.2026.
13. Another petition has been filed on behalf of the accused person namely (i) Panchanan Ghorai praying for waiving/modifying the condition of bail on the ground stated therein.

14. Copy served. Let the same be kept with the record.
15. Fixing **17.04.2026** for appearance of the accused persons, evidence of C.S.W.41 namely Sumita Bhattacharjee, hearing of the petition dated 06.03.2026 filed on behalf of the accused person namely Panchanan Ghorai and written objection, if any, in the meantime.
16. Issue summons accordingly.
17. Requisites at once.
18. The accused persons on Court bail are as before.
19. Let a copy of this order be sent to the Investigating Officer for NIA through the Ld. Special Public Prosecutor for information.
