Order no.11 dated 10.02.2025

To-day is fixed for production of the accused person namely Lakshman Hembram physically before this Court from the J.C. and consideration of charge.

The accused person namely Lakshman Hembram is not produced before this Court from the J.C. either in virtual mode or in physical mode.

Ld. Sr. Counsel for the accused person is present before this Court in virtual mode.

Ld. Counsel for the complainant/ED is present by filing hazira.

At the time of calling out the case record, Ld. Sr. Counsel for the accused person submits that he could not hear the Court proceedings due to some technical glitch and can not follow what is going on in Court.

The Presidency Correctional Home Authority also could not be heard in virtual mode when the direction was given upon the concerned Correctional Home Authority through virtual mode to produce the accused person before this Court on account of some technical problem of the sound system.

It is learnt from the System Officer of this Court that there is some sound problem in the audio video system and the other sides could not hear the Court proceedings of this Court though this Court could hear the other sides.

In view of the non production of the accused person namely Lakshman Hembram before this Court either in virtual mode or in physical mode as well as the submissions of the Ld. Counsel that he could not hear the Court proceedings due to technical glitch specially in the aspect of defective sound system this Court has no other alternative but to adjourn the hearing of the case today.

Accordingly, the case is adjourned today for the ends of justice.

The Superintendent of Presidency Correctional Home Authority is directed to take necessary steps to ensure production of the accused person namely Lakshman Hembram before this Court on the next date fixed in physical mode.

Fix **15.02.2025** for production of the accused person namely Lakshman Hembram physically before this Court from the J.C. and consideration of charge.

To-date i.e. on 15.02.2025 for production of the accused person.

Let a copy of this order be forwarded to complainant/ED for information and necessary action.
