To-day is fixed for production of the accused person namely Lakshman Hembram either in physical mode or in virtual mode before this Court from the J.C., further hearing of the petition dated 15.02.2025 u/s 227 of the Cr. P.C. corresponding to section 250 of the BNSS, 2023 filed on behalf of the accused person namely Lakshman Hembram together with the written objection dated 21.02.2025 filed on behalf of the Prosecution/E.D. and consideration of charge.

The accused person namely Lakshman Hembram is produced before this Court from the J.C. in virtual mode.

Ld. Counsel for the accused person is present before this Court.

Ld. Counsel for the complainant/ED is present by filing hazira.

The accused person is identified by the concerned Jail Authorities and he expressed before this Court that he could see and hear the entire court proceedings without any technical glitch.

The record is taken up for further hearing of the petition dated 15.02.2025 u/s 227 of the Cr. P.C. corresponding to section 250 of the BNSS, 2023 filed on behalf of the accused person namely Lakshman Hembram together with the written objection dated 21.02.2025 filed on behalf of the Prosecution/E.D. and consideration of charge.

At this juncture, a petition has been filed on behalf of the accused person stating that the conducting Ld. Counsel is arguing in another matter before the Court of Ld. Special Judge, C.B.I. 4th Court with his injured leg and on the last occasion i.e. on 20.03.2025 the Ld. Counsel for the accused person requested this Court in presence of the Ld. Counsel is in fasting due to holy Ramadan and therefore an adjournment has been prayed for.

Ld. Counsel for the accused person also prays for fixing the next date for hearing of the instant petition dated 15.02.2025 u/s 227 of the Cr. P.C. after holy Ramadan.

Ld. Counsel for the complainant/ED raises objection to the prayer for an adjournment.

Heard both sides on the point of an adjournment and also on the point of fixing the next date of hearing after holy Ramadan.

Having heard the submissions of both sides and also on consideration of the submission that the conducting Ld. Counsel is ill due to his fasting for holy Ramadan, prayer for an adjournment is considered and allowed for the ends of justice with a direction upon both sides to come ready for hearing on the next date fixed positively.

On submissions of both sides, fix **08.04.2025** for production of the accused person namely Lakshman Hembram either in physical mode or in virtual mode before this Court from the J.C., further hearing of the petition dated 15.02.2025 u/s 227 of the Cr. P.C. corresponding to section 250 of the BNSS, 2023 filed on behalf of the accused person namely Lakshman Hembram together with the written objection dated 21.02.2025 filed on behalf of the Prosecution/E.D. and consideration of charge.
