To-day is fixed for production of the accused persons, further hearing of the petition dated 29.09.2023 filed on behalf of the accused person no.(A-1) praying for an appropriate direction upon the Prosecution in the light of some reported judgments of Hon'ble Court regarding validity of the Notification issued on 06.02.2023 together with the written objection filed on behalf of the Prosecution on 13.10.2023 from the Prosecution side and submission of a fresh report with regard to return of seized articles i.e. the Motor Cycle and CPU to the accused person by the I.O.

The accused person nos.(A-1) and (A-3) have been produced before this Court from J.C.
