The petition dated 29.09.2023 filed on behalf of the accused person no.(A-1) praying for an appropriate direction upon the Prosecution in the light of some reported judgments of Hon'ble Court regarding validity of the Notification issued on 06.02.2023 together with the written objection filed on behalf of the Prosecution on 13.10.2023 from the Prosecution side and the written reply dated 29.04.2024 filed by the accused person no.(A-1) is taken up for hearing.

The accused nos.(A-1) and (A-3) are remanded to J.C. till 25.06.2024.
