To-day is fixed for awaiting original case record from the Hon'ble High Court, Calcutta.

Out of (17) Accused persons, (14) accused persons namely 01) Arun Mahata, 02) Bajinath Tudu, 04) Chhatradhar Mahata, 05) Sundar Mandi, 06) Raju Adak, 07) Dilip Kumar Mahata, 08) Ashok Mahata, 09) Sasadhar Dolui, 10) Bidyut Singha, 11) Bhudeb Mahata, 12) Mrinal Kanti Mahata, 14) Badal Mahata, 15) Lakkhiram Hembram and 17) Jayram Bera @ Jay Bera @ Jaydeb Bera on C.B. are present in Court by filing hazira.

The accused persons namely 03) Chandrasekhar Mahata, 13) Chittaranjan Samanta and 16) Santosh Mahata on C.B. are absent by filing a petition and prays for representation of the accused persons through Ld. Counsel u/s 317 of Cr. P.C. on the ground stated therein.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

Heard both sides on the point of representation of the accused persons u/s 317 of Cr. P.C. through Ld. Counsel.

Prayer is considered and allowed with a direction upon the above mentioned three accused persons to remain present before this Court on the date fixed.

Ld. Counsel for the accused persons is granted liberty to represent the accused person u/s 317 of Cr. P.C.

It appears that the original case is lying with the Hon'ble High Court, Calcutta.

No present status of the case pending before the Hon'ble High Court has yet been submitted by the Prosecution.

A photocopy of An Advocate's letter addressing to the Ld. Registrar General, High Court, Calcutta has been filed on behalf of the Prosecution/NIA.

Ld. Special P.P. of NIA submits that Ld. Counsel for the Prosecution has written a letter requesting the Ld. Registrar General, High Court, Calcutta to look into the matter for further directing the Superintendent of Criminal Section to send back the original case record which is lying with the Hon'ble High Court at Calcutta in connection with CRA 255 of 2020 to this Court. Let the same be kept with the record.

Considering the fact that the original case record is lying with the Hon'ble High Court, Calcutta, the case is adjourned today for the ends of justice.

Ld. Special P.P. of NIA is directed to take necessary steps in this regard for bringing the latest order of the Hon'ble Court in connection with CRA 255 of 2020

On submission of both sides, fix **06.05.2024** awaiting original case record from the Hon'ble High Court, Calcutta.
