Out of (17) Accused persons, (06) accused persons namely 02) Bajinath Tudu, 04) Chhatradhar Mahata, 07) Dilip Kumar Mahata, 08) Ashok Mahata, 09) Sasadhar Dolui and 15) Lakkhiram Hembram on C.B. are present in Court by filing hazira.

The accused persons namely 01) Arun Mahata, 03) Chandrasekhar Mahata, 05) Sundar Mandi, 06) Raju Adak, 10) Bidyut Singha, 11) Bhudeb Mahata, 12) Mrinal Kanti Mahata, 13) Chittaranjan Samanta, 14) Badal Mahata, 16) Santosh Mahata and 17) Jayram Bera @ Jay Bera @ Jaydeb Bera on C.B. are absent by filing two separate petitions and pray for representation of the accused persons through Ld. Counsel u/s 317 of Cr. P.C. on the ground stated therein.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

Heard both sides on the point of representation of the accused persons u/s 317 of Cr. P.C. through Ld. Counsel.

Prayer is considered and allowed with a direction upon the above mentioned eleven accused persons to remain present before this Court on the date fixed.

Ld. Counsels for the accused persons are granted liberty to represent the accused person u/s 317 of Cr. P.C.

It appears that the original case is received by this Court along with a copy of order dated 19.04.2024 passed by the Hon'ble High Court at Calcutta in connection with CRA 255 of 2020 with IA No.:1 of 2020.

Perused the order dated 19.04.2024 wherein the Hon'ble High Court at Calcutta has been pleased to observe as follows:

“Learned Advocate appearing for the National Investigation Agency submits that the appeal is directed against an interim order. He received instruction from his client that since, charge sheet was submitted and the trial is in progress, his client does not wish to proceed with the appeal.

In such circumstances, CRA 255 of 2020 is disposed of as not pressed.

Lower Court Records may be transmitted to the jurisdictional Court forthwith.

Interim application also stands disposed of.”

Heard both sides.

On submission of both sides, fix **13.06.2024** for appearance of all the accused persons and further order.

The accused persons are as before.
