To-day is fixed for appearance of all the accused persons and consideration of charge.

Out of Seventeen accused persons, fifteen accused persons namely Dilip Kumar Mahata, Badal Mahata, Chandra Sekhar Mahata, Mrinal Kanti Mahata, Bhudeb Mahata, Bidyut Singha, Arun Mahata, Ashok Mahata, Chittaranjan Samanta, Lakkhiram Hembramon, Bajinath Tudu, Sundar Mandi, Sasadhar Dolui, Chhatradhar Mahata and Raju Adak on C.B. are present in Court by filing hazira.

The accused persons namely Santosh Mahata and Jayram Bera @ Jay Bera @ Jaydeb Bera on C.B. are found absent.

Ld. Counsels for the accused persons and the Ld. Special P. P. of NIA are present.

Ld. Advocate for accused Jayram Bera @ Jay Bera @ Jaydeb Bera files a petition stating that this accused person is suffering from high fever and as such he is unable to appear before this Court and therefore Ld. Counsel prays for condoning his absence and also prays for an adjournment.

Having heard the submissions of the both sides, the prayers for condoning his absence and also for an adjournment are considered and allowed with a direction upon the accused person namely Jayram Bera @ Jay Bera @ Jaydeb Bera to remain present before this Court on the next date fixed positively i.d. necessary order.

None turns up on behalf of the accused person namely Santosh Mahata.

No step is taken on behalf of the accused person namely Santosh Mahata.

Ld. Counsel for the accused person submits that the accused person namely Santosh Mahata had been present before this Court on each and every date fixed by this Court and today the accused person has not contacted her and as such the Ld. Counsel prays for taking lenient view upon the accused person namely Santosh Mahata giving the accused person namely Santosh Mahata an opportunity to appear before this Court on the next date fixed for the ends of justice.

Ld. Special P.P. of NIA submits that today is fixed for consideration of charge and today accused person namely Santosh Mahata is found absent on calls and therefore Ld. Special P.P. prays for issuance of warrant of arrest against the accused person namely Santosh Mahata.

Heard both sides.

Perused the case record.

Having heard the submissions of both sides, the Ld. Additional Chief Judicial Magistrate, 2<sup>nd</sup> Court, Jhargram is directed to instruct the surety/sureties to take necessary steps to ensure production of the accused person namely Santosh Mahata before this Court on the next date fixed positively i.d. necessary order.

Ld. Advocate for accused person Chhatradhar Mahata files a petition stating that conducting Ld. Counsel is at Chennai Apollo for his treatment and as such he is unable to attend Court today and therefore an adjournment has been prayed for.

Heard both sides on the point of adjournment.

Considering the submissions of both sides and also on consideration of the fact that two accused persons are not present today, prayer for an adjournment is considered and allowed as a last chance with a direction upon all sides to come ready on the next date fixed positively and no adjournment will be allowed on the next date fixed.

On submission of both sides, fix **21.09.2024** for appearance of all the accused persons, production of the accused person namely Santosh Mahata by the concerned surety/sureties and consideration of charge.

All the accused persons are directed to remain present on the next date fixed positively.

Let a copy of this order along with a copy of the bail bond filed on behalf of the accused person namely Santosh Mahata be sent to the Ld. Additional Chief Judicial Magistrate, 2<sup>nd</sup> Court, Jhargram for information and necessary action.

Let a copy of this order be sent to the I.O. of this case through the Ld. Special P.P. of NIA for information and necessary action.
